HOUSE RULES**

GENERAL RULES

Please check your tickets for accuracy before leaving the betting window. Leaving the window with the ticket is deemed an acceptance of the wager by both parties.

- a. Tickets will not be altered or voided prior to the start of an event except at the discretion of management and with the approval of both parties.
- b. Once both parties accept a wager, tickets will not be altered or voided after an event officially begins.
- c. Wagers may only be rescinded with the approval of the chairman of the Nevada State Gaming Control Board.

The Mirage Race and Sports Book reserves the right to refuse any wager, delete, or limit selections prior to the acceptance of any wager.

The Mirage Race and Sports Book is not responsible for lost, stolen, altered or unreadable tickets. Lost or stolen ticket claims will be paid upon presentation of supporting information or documentation. In the absence of such documentation The Mirage reserves the right to wait at least 1 year after the conclusion of the event to make its decision regarding payment.

The Mirage Race and Sports Book will determine minimum and maximum wagers on all race and sports events.

The Mirage Race and Sports Book reserves the right to add, change or delete the Race and Sports Book payout ratio limits.

The Mirage Race and Sports Book reserves the right to add, change or delete the Race and Sports Book House Wagering Rules, subject to regulatory approval.

All future wagers are "action" as long as winner is officially declared, unless otherwise posted or noted on printed media.

The Mirage Race and Sports Book will accept wagers on currently posted terms unless otherwise posted or noted on printed media.

The Mirage Race and Sports Book assumes absolute responsibility for paying the .25% Federal Excise Tax on race and sports wagers.

Any person under the age of 21 years shall not place wagers with or collect winning wagers from any licensed race book, sports pool or pari-mutuel operator.

Pari-Mutuel Race Wagering Accounts are accepted through the Interactive Player Terminal.

Management will make every reasonable effort to resolve disputes. Any unresolved dispute arising as a result of wagers accepted by The Mirage Race and Sports Book shall be resolved as set forth in Nevada Revised Statutes 463.361 - 463.366 and Nevada Gaming Commission Regulation 7A.

RACE BOOK HOUSE RULES

The Mirage Race and Sports Book will consider official results and mutuels, as determined by the track at the time the race is posted official for wagering purposes. Any subsequent overturned decisions will be disregarded.

Once both parties accept a wager, tickets will not be altered or voided after an event officially begins.

Patrons will be notified of odds or line changes in the following manner:

- a. Posted odds for racing events will be shown from the televised track feed whenever available.
- b. Posted proposition wagers will be updated within 10 minutes on the electronic reader boards or the handwritten race and sports boards.
- c. Non-posted events will be announced verbally within the premises of the Race and Sports Book.
- d. Non-posted printed media will be updated on a weekly basis with the date of the latest issue.

All races must be run on date and track scheduled unless otherwise posted or noted on printed media. If a race is postponed and/or rescheduled to a later date, said event will automatically constitute "no action" for betting purposes and wager will be refunded.

A wager accepted after the official post time of a race is void and wager will be refunded.

Minimum wager is \$2.00 on in-house wagers except on trifecta and pick three wagers where the minimum is \$1.00.

All factors involved in race wagering propositions, payoff odds and the determination of winners and losers shall be established by race book management unless otherwise posted or noted on printed media.

An exacta, daily double, pick three, quinella or trifecta wager accepted on a non-exacta, daily double, pick three, quinella or trifecta race respectively constitutes "no action" and money is refunded.

Race wagering tickets will be honored for 1 year after the date of the race event. Winning tickets may be mailed in for redemption. See reverse side of ticket for mail-in redemption instructions. The Mirage is not responsible for tickets not mailed pursuant to instructions on the reverse side of the ticket.

PARI-MUTUEL HOUSE RULES

Please check your ticket for accuracy before leaving the betting window. Leaving the window with the ticket is deemed an acceptance of the wager by both parties.

- a. Tickets will not be altered or cancelled prior to the start of an event except at the discretion of management and with the approval of both parties.
- b. Once both parties accept a wager, tickets will not be altered or voided after an event officially begins.

Payoffs over \$50,000 may be delayed until the next regular banking day.

If a scratch occurs in any pari-mutuel wager, the rules at the respective host track state will apply to the scratched entrants and pools.

All pari-mutuel wagers and payoffs are subject to the rules and regulations of the host track state.

Winning pari-mutuel wagers are paid in accordance with the official results at the track.

Winning pari-mutuel wagers may only be cashed at the property where the ticket was purchased.

Pari-Mutuel wagering tickets will be honored for 1 year after the date of the race event. Winning tickets may be mailed in for redemption. See reverse side of wagering ticket for mail-in redemption instructions. The Mirage is not responsible for tickets not mailed pursuant to instructions on the reverse side of the ticket.

All other non-pari-mutuel house wagering rules apply where not inconsistent with the rules set forth above.

PARI-MUTUEL RACE WAGERING ACCOUNTS

1. Account holder must be at least 21 years of age.
2. Posted House Rules are applicable to Pari-Mutuel Race Wagering Accounts.
3. Patron must personally furnish The Mirage Race and Sports Book with valid proof of identification and social security number.
4. Pari-Mutuel Race Wagering Account transactions cannot be accepted from any individual who has not properly filled out an account application.
5. Management reserves the right to refuse any application.
6. Management reserves the right to suspend or close an account at any time by settling the account balance with the patron. Management reserves the right to refuse deposits to any account for reason it deems sufficient.
7. Management shall keep all wagering account information and transactions confidential except from the patron or as a result of any state and/or federal law that require the book to provide any and all information related to any and all accounts.
8. Only the person named and identified as the account holder can conduct transactions on the account. No agents or representatives will be permitted to access the account.
9. Pari-Mutuel Race Wagering Account transactions are accepted through the Interactive Player Terminal (IPT).
10. Wagers placed through the Interactive Player Terminal are binding when the patron verifies and confirms purchase of wager. A deposit must be made before an account can be opened.
11. Wagers will not be accepted if they exceed the balance in the account.
12. Pari-Mutuel Race Wagering Account withdrawals and subsequent deposits must be made at The Mirage Race and Sports Book during business hours and must be signed and authorized by the account holder. No agents or representatives are allowed.
13. Pari-Mutuel Wagering Account winnings are subject to IRS reporting and/or withholding.
14. Wagers placed through the Interactive Player Terminal are the sole responsibility of the account holder. Management is not responsible for unauthorized access to the account.
15. History of transactions placed through the Interactive Player Terminal will be available for a period of 60-days.

NON- PARI-MUTUEL HOUSE RULES

Payoff limits are as follows (Exception: see greyhound payoff limits)

STRAIGHT BET

Full track odds on the first \$100

Thereafter: Win limits 30-1 Place limits 12-1 Show limits 6-1

PARLAYS

Win limits 100-1 Place limits 40-1 Show limits 20-1

In the event of a scratch, parlay is reduced to the next lower number of parlays. A scratch in a two-horse parlay becomes a straight wager. Entries and fields go as one, unless deemed no action by the host track.

DAILY DOUBLE

Full track odds on the first \$20

Thereafter: limit 150-1

Entries and fields go as one unless deemed no action by the host track. No consolation daily doubles. If one horse is scratched money will be refunded.

EXACTAS

Full track odds on the first \$20

Thereafter: limit 150-1

Entries and fields go as one unless deemed no action by the host track. If one horse is scratched money will be refunded.

QUINELLAS

Limit 150-1

House quinellas will be offered on designated races only. Please check boards and scratch sheets for available races. If one horse is scratched money will be refunded. Entries and fields go as one, unless deemed no action by the host track.

In the event of a dead heat for win, the house quinella will be the higher of the two quinellas as normally computed. Win price of the winner times half the place price of the second horse.

House quinellas must have at least 6 betting interests for action. In case of a scratch reducing the field to less than 6 betting interests, all quinella wagers will be refunded.

If the same entry or field horse finishes first and second, then the quinella is computed by multiplying the win price of the entry or field horse times the show price of the horse that finishes third.

If an entry or field horse wins a race and the other half of the entry or field horse finishes in a dead heat for second, then the entry is considered as winning the race and the place price of the horse other than the entry or field horse involved in the dead heat for second will be used to compute the quinella.

House quinella wagers will be deemed "no bet" and monies refunded if an entry or field entry finishes first, second and third.

PICK THREE

Limit 250-1

In the event of a late scratch in one of the designated pick three races; the bettor will automatically receive a refund. The Mirage Race and Sports Book does not recognize consolation pick three payoffs.

TRIFECTA

Limit 500-1

The Mirage Race and Sports Book does not recognize consolation trifecta payoffs.

GREYHOUND PAYOFF LIMITS

STRAIGHT BET

Win Limits 15-1 Place Limits 6-1 Show Limits 3-1

QUINELLA

Track Quinella payoff limit 100-1
All other Quinella rules apply

EXACTA

Track Exacta payoff limit 100-1
All other Exacta rules apply

DAILY DOUBLE

Track Daily Double payoff limit 100-1
All other Daily Double rules apply

TRIFECTA

Track Trifecta maximum payoff limit 299-1

In those cases, in which a bettor correctly selects all three winning finishers but there is no winning trifecta ticket at the track, the player will receive 299-1. The Mirage Race and Sports Book does not recognize consolation trifecta payoffs. **Maximum payout of \$5,000 per ticket**

SPORTS BOOK HOUSE RULES

Management will keep a record of all pointspreads, odds, final scores and related betting proposition statistics to protect both the customer and Sports Book in case of an obvious mechanical or human error.

Patrons will be notified of odds or line changes in the following manner:

- a. Posted odds will be changed automatically on the electronic reader boards.
- b. Posted odds will be changed manually on all handwritten race and sports boards.
- c. Non-posted events will be announced verbally within the premises of the Race and Sports Book.
- d. Posted changes will be updated within 10 minutes on the electronic reader boards or the handwritten race and sports boards.
- e. Non-posted printed media will be updated on a weekly basis with the date of the latest issue.

22.1205 Prohibits the following:

- a) Wagers on any amateur sport or athletic event other than Olympic sporting or athletic events and collegiate sporting or athletic events as set out in this regulation.
- b) Wagers on any sport or athletic event, which the licensee knows or reasonably should know, is being placed by, or on behalf of an official, owner, coach, or staff of a participant or team or participant in that event.
- c) Wagers on the outcome of any election for any public office both within and without the State of Nevada.
- d) Wagers on any athletic sports event sanctioned by a governing body where the Chair has made a finding that the governing body is not effectively supervising such event or not ensuring the integrity of such event.

All baseball, basketball, and hockey games must be played on date and site specified for action unless specified otherwise on printed media. All other events including football must be held within one week of scheduled date and at originally specified site to be considered action unless specified otherwise on printed media.

For betting purposes, the winner of an event or game will be determined on the date of the event's conclusion according to house wagering rules. The Mirage Race & Sports Book does not recognize suspended games, (Exception: see baseball rules) protests, and overturned decisions/results for wagering purposes. Once competition is official, wagers will be paid on the initial results.

On all future event wagers involving a recognized sports organization; i.e. Super Bowl, World Series, etc., the winner as determined by the league commissioner, chairman, or other authoritative officer at the conclusion of said event and will also be declared the winner for betting purposes.

In two-way match-up proposition wagers, specified player, team or animal must start for action or wager is refunded. In the event that any participant "starts" but fails to finish for any reason, the opponent shall be deemed the winner for betting purposes.

Games are official after:

Football (professional and college): 55 minutes of play

Basketball (professional): 43 minutes of play

Basketball (college): 35 minutes of play.

Hockey (professional or college): 55 minutes of play

Baseball: see baseball disclaimer

Soccer: 90 minutes of play plus any added injury time

Auto Racing: All wagers will be settled according to the unofficial results reported immediately after the conclusion of the race by the governing organization. Any changes to the finishing order that occurs based on appeals, penalties or scoring malfunctions after the race has concluded, will not be recognized for wagering purposes.

Olympics: Games/results are official once there is an award ceremony for that particular event

Boxing/MMA (professional and amateur):

When the bell is sounded signifying the start of the opening round, the bout is considered official for betting purposes, regardless of the scheduled length, weight, classification and/or championship sanction. In round proposition bets, when the bell sounds signifying the end of a round, that is considered a full round for wagering purposes. If the bout is officially stopped prior to the bell, that round is not considered a full round. If the fight is stopped for any reason in between rounds, the fight will for wagering purposes, be determined to have stopped in the last completed round. For all "pick the round" propositions, if the length of the bout is changed from that posted or noted on printed media, all wagers are deemed "no action" and refunded.

All specified period(s) wagers and non-full game wagers:

All specified period(s) wagering propositions must be played to conclusion of specified period(s) of play or will be deemed "no action" and money refunded. Overtime period(s) are included as part of the second half.

All other sporting events with a scheduled length of play or time limit must play to conclusion or have five minutes or less of scheduled playing time remaining when the event concludes, or wagers will be deemed "no action" and refunded.

In Boxing/MMA:

- (a) "K.O." proposition wagers: "K.O." includes knockout, technical knockout, disqualification, or any other stoppage unless otherwise posted or noted on printed media.
- (b) "Decision" proposition wagers: "Decision" means fight must go to the judge's scorecard(s) to determine a winner; including technical decision.
- (c) "Draw" proposition wagers: "Draw" means fight must go to the judge's scorecard(s) and be declared a draw; including technical draw.

Baseball:

Baseball games are official after five (5) innings of play, unless the home team is leading in which event the game is official after four and one half (4 1/2) innings. Thereafter, if a game is called or suspended, the winner is determined by the score after the last full inning unless the home team scores to tie or take the lead in the bottom half of the inning in which case the winner is determined by the score at the time the game is called. When wagering on total runs or run lines, the game must go 9 full innings (8 1/2 if the home team is ahead) to have action

All Major League Baseball playoff games will have action regardless of date played and/or completed unless specified otherwise on printed media. Game winner will be paid based on the official winner determined by Major League Baseball.

Baseball Specified Inning Propositions:

In specified inning wagers, game must go full specified innings to be official, unless the home team is leading the bottom half of specified inning prior to completion of specified innings(s). For totals and run lines, game must go the full specified innings and listed pitchers must start.

Rules for baseball propositions are the same as those for baseball totals, unless specified otherwise on printed media.

Baseball wagers are accepted in the following manner:

- a. Action - Team against team, regardless of the starting pitcher.
- b. One specified pitcher - A wager on or against one specified pitcher, regardless of the other starting pitcher. Specified pitcher must start or wager is deemed "no action." and wager is refunded.
- c. Both specified pitchers - A wager that specifies both starting pitchers must start for action. Any variation constitutes "no action." and wager is refunded.

*In the event of a pitcher(s) change prior to the start of a baseball game, money line odds will be adjusted to the opening price of the new pitching matchup.

Note: Each team's starting pitcher is defined for wagering purposes as the pitcher that throws the initial pitch.

In the event of a shootout in hockey, one goal will be added to the winning team and one goal to the total. When wagering on "totals", overtime periods are included as part of the final score.

For soccer, golf, and tennis, refer to posted or printed media for specific disclaimers.

Sports wagering tickets will be honored for 1 year after the date of the event. Winning tickets may be mailed in for redemption. See reverse side of wagering ticket for mail-in redemption instructions. The Mirage is not responsible for tickets not mailed pursuant to instructions on the reverse side of ticket.

Nevada Gaming Commission Regulation 22.061 requires identification to be verified before issuing payments that exceed \$10,000. Accordingly, we are required to obtain a copy of your identification credential before issuing payment by mail. We will accept a copy either by mail or email.

In the event of a tie in a straight wager, wager is considered “no action” and money is refunded.

In a two-team teaser involving a tie, the wager is considered no action and money is refunded regardless of the outcome of the other team. Otherwise, a tie or no action reduces teaser to next lower number of plays.

Buying Points: Player may buy half point(s) on straight wagers in football and basketball at the odds selected by management.

MOBILE WAGERING ACCOUNTS
Race & Sports Book
Rules and Regulations

1. Account holder must be at least 21 years of age.
2. MGM Resorts International Race and Sports Book posted House Rules and regulations are applicable to Mobile Wagering Accounts. House Rules are available to view in the Support area of Mobile Wagering App.
3. For an individual account the patron must personally appear and furnish MGM Resorts International Race and Sports Book with valid proof of identification and social security number prior to activating an account. For a business entity account the entity patron must provide the information required pursuant to Nevada Gaming Commission Regulation 22.155.
4. Mobile Wagering Account transactions through the Mobile Wagering App cannot be accepted from any individual who does not have a valid Mobile Wagering Account which is in good standing.
5. Management reserves the right to refuse any application.
6. Management reserves the right to suspend an account for reasons it deems sufficient.
7. Management reserves the right to terminate and settle the account balance with the patron for reasons it deems sufficient.
8. Management shall keep all wagering account information and transactions confidential except from the patron, affiliates or as a result of any state and/or federal law or legally sufficient subpoena or other court document that require the book to provide any and all information related to any and all accounts.
9. Only the person(s) named and registered on the account may conduct transactions on the account. For a business entity account the designated individual(s) of the business entity may conduct transactions and be permitted access to the account.
10. Mobile Wagering Account transactions are accepted through the Mobile Wagering App.
11. Wagers placed through the Mobile Wagering App are binding when the patron verifies and confirms purchase of wager displayed on the screen.
12. Wagers will not be accepted if they exceed the balance in the account.
13. Mobile Wagering Account withdrawals and subsequent deposits made at any MGM Resorts International authorized location during business hours must be signed and authorized by the account holder.
14. Mobile Wagering Account winnings are subject to IRS reporting and/or withholdings.
15. Wagers placed through the Mobile Wagering App are the sole responsibility of the account holder. Management is not responsible for unauthorized access to the account.

16. History of transactions placed through the Mobile Wagering App will be available for a minimum of 60-days in the My Wagers and statement pages.
17. If you do not place any wagers for 16 consecutive months your account will be suspended from play and classified as dormant. To reactivate the account, you must appear in person at any location which is available for account opening to re-validate your identity. We may close the dormant account at our own discretion at any time.
18. Unless otherwise stated, all rules apply to both wagers made in person and to wagers made using the playMGM Mobile Wagering App.
19. For wagers made through the Mobile Wagering App, the terms of your wager are displayed before you tap "Place Bet," which action is deemed an acceptance of the wager terms by you. Our acceptance of the wager request is displayed in a confirmation message on your mobile device and can be reviewed in the My Wagers section of the Mobile Wagering App at any time.
20. Payment of winning wagers will be made when MGM Resorts International confirms and posts results. Winning wagers will be applied directly to your Mobile Wagering Account.
21. Wagers may only be accepted from within the state of Nevada. MGM Resorts International Race and Sports Books are prohibited by law from accepting wagers originating from outside the state of Nevada.
22. Changes will automatically be updated within the Mobile Wagering App. Any changes on bet-selections will require your acceptance of the revised change before your wager can be confirmed.
23. Mobile Wagering Accounts are subject to an audit at the discretion of management at any time. If it is determined that account balances are inaccurate or in error as a result of posting errors, late decision adjustments, modifications mandated by notifications or decisions of the Nevada Gaming Control Board or other system errors, the Mobile Wagering Account will be adjusted to reflect the findings of the audit. An account may also be adjusted as a result of the resolution of a customer dispute. In the event an adjustment would result in a negative balance in the account, all activity in the account will be suspended until agreement on the adjustment is reached between the account holder and system operator. If the parties are unable to agree on the adjustment the matter will be submitted to the Nevada Gaming Control Board for resolution as a customer dispute.
24. Mobile Wagering Account rules and regulations are subject to change by management at any time.
25. You may also deposit and withdraw funds using the playMGM pre-paid debit card when associated with your playMGM Mobile Wagering Account. Other debit cards may not be used.

LIVE ACTION IN-PLAY HOUSE RULES

Football

Overtime periods count towards the point line, total, and money line for full game and second half wagers, unless otherwise specified.

Overtime will not count in any wagers involving quarters, first half, or a specific length of play wager.

Specific length of play proposition(s) must be played to the conclusion of the specified portion of play or will be deemed “no action” and refunded.

Wagers for all full-game propositions are valid providing at least 55 minutes of play occurred, unless otherwise specified.

Basketball

Overtime periods count towards the point line, total, and money line for full game and second half wagers, unless otherwise specified.

Overtime will not count in any wagers involving quarters, first half, or a specific length of play wager.

Specific length of play proposition(s) must be played to the conclusion of the specified portion of play or will be deemed “no action” and refunded.

Wagers for all full-game propositions are valid providing at least 43 minutes of play occurred for professional games, unless otherwise specified.

Wagers for all full-game propositions are valid providing at least 35 minutes of play occurred for collegiate games, unless otherwise specified.

Wagers for all full-game propositions are valid providing at least 35 minutes of play occurred for international games, unless otherwise specified.

Baseball

Money Line, Run-line, and Totals are considered official at the completion of nine full innings of play OR after the completion of 8.5 innings with the home team winning otherwise all bets are considered “no action” and refunded.

Wagers on specified length of play (i.e. 1st inning, 3 innings, and 5 innings) must play to the conclusion of the specified length of play and listed pitchers must start or the wager will be considered “no action” and refunded.

Extra innings count towards the money line, Run-line and total and any other specified proposition, unless otherwise specified.

HOCKEY

Wagers for all full-game propositions are valid providing at least 55 minutes of play occurred, unless otherwise specified.

Overtime periods count towards the point line, total, and money line for full game wagers, unless otherwise specified. In the event of a shootout in hockey, one goal will be added to the winning teams score and only one goal towards the total.

SOCCER

TOTAL WAGERS: are for 90 minutes of play PLUS added stoppage injury time by the officials. Extra time, overtime, and shootouts do not count towards the final score, unless otherwise specified in the wagering proposition.

TENNIS

All live action in-play wagers are considered action.

BOXING/MMA

All live action in-play wagers are considered action.

GOLF

All live action in-play wagers are considered action, winner will be determined in accordance to the tournaments official results.

AUTO RACING

All live action in-play wagers are considered action.

All wagers will be settled according to the unofficial results reported immediately after the conclusion of the race by the governing organization. Any changes to the finishing order that occurs based on appeals, penalties or Scoring malfunctions after the race has concluded, will not be recognized for wagering purposes
