Chris Magee has been promoted to Vice President of Sustainable Facilities, while Yalmaz Siddiqui joined MGM Resorts as Vice President of Corporate Sustainability.

### **Chris Magee, Vice President of Sustainable Facilities**

In Magee’s new capacity as Vice President of Sustainable Facilities he is responsible for providing strategic direction and operational oversight to the development and implementation of large-scale, renewable applications and energy efficiency programs to reduce the environmental impact of company operations. This includes leveraging existing systems, new technology, waste management and statistical analysis to further the continual improvement of operations across the enterprise. He is also responsible for ensuring the company is in compliance with U.S. Environmental Protection Agency and Clark County Department of Air Quality permitting.

Magee has more than 25 years of experience with MGM Resorts and is a day-one member of the Corporate Sustainability Division, which was established in 2006. Prior to joining the Corporate Sustainability Division, he served as a supervisor in Bellagio’s Mechanical

Engineering Department. In that role, he was responsible for overseeing the operation and maintenance of the property's mechanical systems, as well as its Central Plant. In addition, he played an integral role in leading environmental projects for the growing company enterprise, along with driving Bellagio's energy conservation efforts that resulted in substantial savings in water, power and gas.

Magee's passion for resource conservation throughout Nevada and the United States, as well as his expertise on lighting and energy efficiency, has earned him national recognition. He has visited the White House several times, representing MGM Resorts when the company was recognized for its achievements in energy efficiency. An engaged thought leader in his field, he has held a number of volunteer roles on local and national sustainability committees. He serves as the chair of the Conservation District of Southern Nevada. He also currently serves as the Steering Committee Chair of the newly-developed Department of Energy Hospitality for the Better Buildings Alliance. Magee is also a longtime member and past chair of the Lighting & Electrical sub-committee for the U.S. Department of Energy Better Building Alliance.

### **Yalmaz Siddiqui, Vice President of Corporate Sustainability**

As Vice President of Corporate Sustainability, Yalmaz Siddiqui is responsible for leading a range of environmental sustainability initiatives for the company, including sustainable sourcing, employee engagement, green conventions, food waste reduction and waste management. In addition, Siddiqui will provide leadership and oversight for the development of an advanced sustainability strategy framework for MGM Resorts, including metrics and goals, project accountability, roles, and reporting strategy.

Siddiqui brings an extensive background in corporate sustainability to his new role. He most recently served as Senior Director of Sustainability at Office Depot. During his ten-year tenure with the global company, he was responsible for leading the strategy and implementation of a series of social and environmental sustainability programs across the organization. While at Office Depot, Siddiqui helped the company increase sales of environmentally preferable products from \$1.2 billion to \$3.2 billion; reduced carbon emissions by more than 40 percent; and achieved recognition from *Newsweek Magazine* as America's #1 large green retailer for three consecutive years.

He also served as a management consultant at IBM and PwC for a decade where he focused on business-to-business customer relationship management and performance improvement strategy.
